## **Nigel Hawke Racing Club Rules & Conditions**

1. All members must be at least 18 years old.
2. Membership is not available to any person who is currently "warned off" by the British Horseracing Authority.
3. The management reserves the right to refuse membership or limit membership numbers at its sole discretion.
4. Membership runs for 12 months from the date of joining.
5. Membership of the Club is not intended in any way to be an investment. Returns are limited solely to the enjoyment of horse racing.
6. Membership of the Club does not convey any ownership rights in any of the horses which may run in the Club's name.
7. Membership is personal, is non-transferable and cannot be sold or shared.
8. Membership cannot be used for any commercial or promotional purposes.
9. All horses which run in the Club's name will be leased to the Club at zero cost.
10. Club members will be eligible to receive 50% of prize money after standard Weatherbys deductions and will be distributed at the end of the annual membership period on a pro-rata basis in line with the members' respective periods of membership during that period.
11. All decisions regarding the training and racing of the horses will be made solely by the Management and the Trainer.
12. Fees may be paid monthly (1st of each month) or annually in advance.
13. Members are protected from any additional outlay. The total cost of membership is limited to the monthly / annual membership fee.
14. The Management will endeavour to have a minimum of 4 horses running in the Club's name at all times.
15. Notwithstanding 14 above, the Management reserves the right to remove horses from the Club and to substitute alternatives at their sole discretion.
16. The Management will, as often as possible, arrange for additional horses to run in the Club's name. This will normally be younger horses making their racecourse debuts for the Trainer.
17. In the event of any horse running in the Club's colours being offered for sale, Members will be given 'first refusal' to purchase before it is offered to other potential purchasers.
18. The Management will endeavour to provide free racecourse badges to all members who notify the Club that they intend to attend on race days. 48 hours' notice will be required to enable badges to be made available on the day.
19. In the event of insufficient free badges being available, the Management will endeavour to negotiate discounted entry fees.
20. Subject to 21 below, no refunds of membership fees will be made in any circumstances.
21. Membership will automatically cease on death of a member. Where fees have been paid in advance, a refund will be made in respect of any unused period from the date of death to the end of the membership period.
22. Membership will continue after the initial 12 month period unless the member notifies the Management in writing prior to the end of the current membership period. Address for notification is: Nigel Hawke Racing Club, Thorne Farm, Stoodleigh, Tiverton, Devon EX16 9QG.
23. The Management reserves the right to discontinue the activities of the Club in the event that its continued operation becomes financially unviable.
